

Black Walnut Hull Extract, Oregano Oil, and Pau D'arco could interact with blood thinners<sup>29,30</sup>. Neem has liver and kidney risks at high doses and affects diabetes medications<sup>31</sup>. Biotin is generally safe but can interfere with certain lab tests<sup>32</sup>.

#### **CANXIDA RESTORE**

Lactobacillus acidophilus, Lactobacillus plantarum, Lactobacillus casei, and Lactobacillus rhamnosus, along with Bifidobacterium bifidum and Bifidobacterium longum, are probiotics that are generally considered safe and beneficial for gut health<sup>33</sup>. Amylase, Cellulase, Glucoamylase, Hemicellulase, Invertase, Protease, and Serratiopeptidase are digestive enzymes that break down carbohydrates, proteins, and fibers, promoting better digestion and nutrient absorption. While these science-backed ingredients are generally safe for most people and may be preferred by older patients, specific health conditions or certain medications may necessitate further consultation.

However, Candida species resistant to terbinafine have emerged<sup>6,7</sup>. By comparison, CanXida contains safe, all-natural ingredients with broad, scientifically verified mechanisms of action. This means that while conventional therapies are prone to resistance, CanXida is less likely to yield antifungal resistance and has reduced potential for drug interactions. CanXida is also cheaper than conventional therapies and available without a prescription. Furthermore, our more gentle formulations make CanXida products less irritating to the digestive system.
