However, leveraging this knowledge to benefit clients requires clinical expertise and knowledge of modern formulation technologies. One of the CanXida co-founders worked with patients in a clinical setting for thirty-four years and is an astute scholar of Candida and related diseases. He distilled his experience and expertise into CanXida's formulations, combining efficient dosage, slow-release technology, and high-quality, evidence-backed ingredients to provide comprehensive solutions to Candida*.

Our dedication to science-backed ingredients and quality has improved the lives of our clients, some of whom were in dire situations before discovering CanXida¹. We believe in patient empowerment and put all our effort into providing tools for our clients to be proactive in their fight against Candida. To this end, we have produced 3000 YouTube videos, thousands of articles, and a widely recognized book on Candida that clinicians use globally. We actively engage in community and corporate social responsibility (CSR) efforts, supporting various organizations, including the American Association of Naturopathic Physicians and Naturopathic Associations in New York, Connecticut, Washington, and Oregon, among other sites. CanXida is recognized globally as a leader in supplementation for gut health, microbial balance, and tackling Candida-related diseases.

UNDERSTANDING CANDIDA AND GUT HEALTH

Candida is a genus of fungi present on and in our bodies². Under normal conditions, it can be a healthy commensal microbe; however, in some circumstances, it can expand beyond its homeostatic niche and cause disease². Candida is the most prevalent disease-causing fungus, and the global incidence of Candida-related disease is increasing³. Within the gut, the overgrowth of Candida causes dysregulation of the microbiome², which is essential not only for digestive wellness but is now increasingly recognized as a central facet of overall well-being, including mental health⁴⁻⁶. Candida outgrows the healthy microbes we need for digestion and can adhere to the lining of the intestine, forming biofilms that both protect Candida and aid more severe forms of its pathogenicity⁷. Initially, Candida can cause localized infection and digestive discomfort; however, if left untreated or if treatment fails, Candida can invade and colonize internal organs and the bloodstream⁸. These are severe health conditions with high mortality rates. Thus, prevention and early action against Candida are crucial, especially if you are at risk for Candida infection.

Many strains of Candida have become resistant to conventional therapies⁹⁻¹¹, making Candida an alarming global health concern. Thus, providing alternative, less resistance-prone methods to tackle Candida is an essential priority for the field. Risks for Candida include prolonged courses of antibiotics, depleted immunity, and co-morbidities like diabetes and cancer^{12,13}. Older adults are particularly vulnerable as they are the most likely to possess one or more of these risk factors for Candida overgrowth^{14,15}. High-stress lives and low-quality diets also contribute to Candida risk, making Candida prevention a priority for all age groups.

THE CANXIDA DIFFERENCE: PRODUCT DEVELOPMENT AND INGREDIENTS

At CanXida, we took our time and used decades of experience and knowledge to develop the optimal anti-Candida supplements. An extensive scientific literature supports all of our products' ingredients¹⁶⁻¹⁸. However, our vast clinical experience lets us truly be customer-centric rather than simply claim to be, as many of our competitors do.

Once Candida has been removed*, the gut needs to be replenished with healthy bacteria. **CANXIDA RESTORE (FORMULA RST)** is a diverse probiotic supplement that aims to bring back comfort and digestive function to the gut after CanXida Remove (Formula RMV) has done its job.

To support recovery and keep Candida at bay, **CANXIDA REBUILD (FORMULA RBD)** is a wide-reaching multivitamin that promotes immune function, helps restore patient energy levels, and enables self-empowerment.

CanXida ReCharge (Formula RCH) contains 36 high-quality ingredients which support a range of bodily systems, including digestion, liver, brain, and immune function, helping maintain energy levels and improve cognition.

By eliminating Candida and other harmful microbes*, CanXida Remove (Formula RMV) has helped our customers get back to enjoying the food they love without worrying about severe reactions. Our comprehensive (and completely free) dietary guide accompanies our formulations to expedite the natural healing process.

GUT-BRAIN CONNECTION:

So many of our clients complained of brain fog and an inability to concentrate, and so many of them found relief with our formulations. Until recently, mental health and gut health were thought to be unrelated. However, recent research has shown the two are intricately linked, with the microbiome playing a central role in their cross-talk. By restoring microbiome balance, CanXida promotes gut health, positively impacting mental clarity, mood, and overall brain function.* Indeed, in a recent meta-analysis, probiotics were proposed to positively affect mild-moderate depression¹⁹. CanXida ReCharge (Formula RCH) contains specific ingredients like glycine and choline, which are essential for cognitive function.

INFLAMMATION REDUCTION:

Inflammation is a symptom of infection related to diseases like arthritis and cancer²⁰. Thus, controlling chronic inflammation is essential for comfort and disease prevention. CanXida's formulations have anti-inflammatory properties, which can help manage conditions like joint pain, skin issues, or gastrointestinal inflammation caused by Candida*.

ENERGY AND VITALITY:

Our products boost energy levels and improve overall vitality without relying on stimulants like caffeine. The probiotics found in CanXida Restore (Formula RST) have been scientifically shown to increase energy levels in athletes²¹. Furthermore, by reducing inflammation and digestive issues, these healthy bacteria allow us to get more energy from food. CanXida ReCharge (Formula RCH) provides energy in the form of medium-chain triglycerides and matcha green tea, helping to prevent fatigue.

SKIN HEALTH:

Opportunistic pathogens like Candida are found on our skin and are common sources of irritation and infection. However, many current therapeutic options for skin issues rely on pharmaceuticals with a narrow range of action. CanXida contains all-natural ingredients that are scientifically proven to tackle Candida. Garlic extract has been shown to cure cutaneous candida infection²², thus providing a natural answer to Candida.

SCIENTIFIC BACKING

Many companies cut and paste formulations without clinical or scientific knowledge, but not CanXida. We know what's in our supplements and why. Here is a brief breakdown of our formulations and the importance of their ingredients.

CANXIDA REMOVE (FORMULA RMV):

CanXida Remove (Formula RMV) is based on scientific research for a combined holistic and conventional approach to treating Candida and pathogenic fungi*. Its 12 sustainably-sourced ingredients, selected for their efficacy, include Grapefruit Seed Extract, which destroys yeast cells and disrupts bacterial membranes²³; Berberine Concentrate, which enhances antifungal potency²⁴; Clove and Garlic, which exhibit strong antifungal activities^{25,26}; Caprylic and Undecylenic Acid which are effective against Candida biofilms^{27,28}; Betaine HCl, which reduces stomach pH²⁹; Black Walnut Hull Extract³⁰ and Pau D'arco³¹, both with potent antifungal properties; Neem, with antimicrobial effects³²; Biotin, which plays a role in immune cell function³³; and Oregano Oil, which inhibits Candida biofilm formation³⁴. Each ingredient is substantiated by specific studies demonstrating their roles in combating Candida and related infections.

For the best results with CanXida Remove (Formula RMV), the following guidelines should be followed:

- Take a tablet with food; CanXida Remove (Formula RMV) is best taken during (in the middle or at the end of) a high-protein meal or snack.
- Take tablet(s) in the morning and/or at night.
- The starting dose is dependent on stomach sensitivity.

CANXIDA RESTORE (FORMULA RST):

CanXida Restore (Formula RST) combines 6 probiotic strains and 7 digestive enzymes to combat yeast, parasites, and harmful bacteria and support digestion. Each capsule contains over 18 billion beneficial bacteria, which are effective against yeast and aid digestive function. The probiotic strains include *Lactobacillus acidophilus*, which inhibits *Candida* growth³⁵; *Lactobacillus plantarum*³⁶, which enhances intestinal barrier function; *Lactobacillus casei*, which is beneficial for intestinal disorders³⁷; *Lactobacillus rhamnosus*³⁸, which supports gut health; *Bifidobacterium bifidum*³⁹, which stimulates vitamin production and reduces gut inflammation; and *Bifidobacterium longum*, known for its positive gastrointestinal effects⁴⁰. The digestive enzymes, including Amylase⁴¹, Cellulase⁴², Glucoamylase⁴³, Hemicellulase⁴², Invertase⁴⁴, Protease⁴⁵, and Serratiopeptidase⁴⁶, are incorporated to enhance probiotic effects and aid in various aspects of digestion, such as carbohydrate breakdown, reducing bloating, and improving bowel movements. This science-backed formulation is specifically designed to improve intestinal health, support holistic wellness, and manage *Candida*-related issues*.

For the best results with CanXida Restore (Formula RST), the following guidelines should be followed:

- CanXida Restore (Formula RST) is specifically designed to bypass the stomach and break down in the small intestine.
- CanXida Restore (Formula RST) contains the enzyme serratiopeptidase, which works best on an empty stomach.
- Both CanXida Remove (Formula RMV) and CanXida Restore (Formula RST) are best taken together for 3-6 months at a minimum.

CANXIDA REBUILD (FORMULA RBD):

This scientifically formulated health supplement is enriched with essential vitamins and minerals to bolster the immune system. Vitamin A is instrumental in T-cell activation and maintaining epithelial barrier integrity⁴⁷. Vitamin C aids in neutrophil migration, expedites wound healing through collagen synthesis, and assists in post-immune response clearance⁴⁸. Vitamin D is crucial in immune response regulation and is vital for dietary calcium absorption^{49,50}. Essential B vitamins, including B6⁵¹, B12⁵², and Folate⁵³, are key to immune cell proliferation, antibody production, and cytokine generation. Vitamin E supports T-cell communication and immune signaling⁵⁴. Minerals like Iron, Zinc, Selenium, and Magnesium are integral for the activation and functioning of various immune cells, including T-cells, B-cells, and natural killer cells, enhancing the body's ability to combat infections and maintain robust health⁵⁰. This blend ensures a comprehensive eco-friendly approach to strengthening immune defenses.

For the best results with CanXida Rebuild (Formula RBD), the following guidelines should be followed:

- The standard dosage for CanXida Rebuild (Formula RBD) is 1-2 tablets/day.
- CanXida Rebuild (Formula RBD) has sustained release; tablets are best taken with food and can also be blended into food.
- A minimum treatment of 1-2 months is recommended to build up health, but CanXida Rebuild (Formula RBD) can be taken for a prolonged time for healthy gut maintenance.

CANXIDA RECHARGE (FORMULA RCH):

CanXida ReCharge (Formula RCH) is a comprehensive supplement blend, offering an impressive array of 21 vitamins and minerals that surpasses some multivitamins in nutrient coverage. CanXida ReCharge (Formula RCH) supports a broad range of physiological functions, including immune system enhancement, energy production, and metabolic health. Key vitamins such as Vitamin C contribute to antioxidant activity and immune defense, while Vitamin D enhances calcium and phosphorus absorption, crucial for maintaining physical health^{48,55}.

B vitamins like Thiamine, Riboflavin, Niacin, B6, Folate, and B12 play significant roles in cellular metabolism, immune modulation, and energy production^{51,56}. Minerals such as Calcium, Iodine, Magnesium, and Zinc are integral for biological processes, including brain health, muscle function, and immune response^{50,57-59}. Additionally, the formula includes amino acids like L-Glutamine^{60,61}, Glycine^{62,63}, and Taurine⁶⁴⁻⁶⁶ for protein synthesis, liver protection, and energy generation. Herbal extracts like Larix laricina^{67,68}, Matcha Green Tea⁶⁹, and Ginger root powder^{70,71} offer antioxidant properties and support for digestive health. The supplement also contains 14g of vegan-friendly organic brown rice and pea protein per scoop, alongside natural sweeteners like Stevia and Xylitol, to support fitness goals without adverse effects^{72,73}. Other ingredients, such as Medium Chain Triglycerides and natural vanilla flavor enhance energy and improve taste, ensuring adherence to the supplement regimen.

For the best results with CanXida Restore (Formula RST), the following guidelines should be followed:

- Take one scoop of CanXida ReCharge (Formula RCH) on an empty stomach.
- Consult your healthcare provider for optimal dosage.

The facility where CanXida is manufactured is accredited with GMP (Good Manufacturing Practices) by the National Sanitation Foundation (NSF) and is registered with the Food and Drug Administration (FDA). It is also a member of the National Products Association (NPA). CanXida products and their ingredients are subjected to extensive testing and quality checks to guarantee safety and efficacy for our customers. This includes screening for heavy metals such as arsenic and lead, harmful microorganisms like E. coli and yeasts, and assessing potency and purity to prevent adverse drug interactions, which is particularly crucial for older adults. Before being marketed, CanXida's ingredients and final products are tested by the manufacturer and receive certificates of analysis, assuring their safety and effectiveness. As an additional step, we also send all of our formulations for third-party testing to Eurofins, who are global leaders in product analysis. This ensures all of our formulas are safe and effective for our clients.

COMPREHENSIVE COVERAGE

CanXida vastly outstrips competitors when it comes to the sheer breadth of ingredients. For instance, CanXida ReCharge (Formula RCH) contains 36 premium ingredients, while CanXida Remove (Formula RMV) has 12 all-natural ingredients, all of which have scientifically proven anti-Candida properties.
